ABOUT CABA

The Cuban American Bar Association (CABA) enters its fourth decade of excellence and dedication to the legal profession. In 1995, as part of its mission to promote diversity and opportunity in the legal services community, CABA launched the Cuban American Bar Foundation, to manage and promote efforts to endow scholarships at Florida law schools. Twenty years later, these endowments have exceeded half a million dollars, but with rising tuition costs, more must be done! Fundraising events such as the CABA Art in the Tropics and the annual Benefit & Installation Gala, enable the mission and assist the Foundation with its endowment of the CABA Scholarship Fund. In the past several years, over one hundred-fifty-thousand dollars have been raised towards a two hundred-fifty-thousand-dollar goal.

Due to the growing concern of the Florida Bar regarding the challenges in addressing the legal needs of indigent Spanish speakers in Miami Dade County, the CABA Pro Bono Project was created.
